Payment Policy: ACPA does not offer reduced registration fees for partial attendance. Payments must be paid in full by personal or institutional check, U.S. money order, or credit card at the time of registration. Payments must be made in U.S. funds and drawn from a U.S. bank. A processing fee will be added at checkout for credit card transactions only. The processing fee includes the amount the credit card companies charge ACPA for each transaction. These fees vary by credit card company.

Cancellation Policy: There is a 100% refund for cancellations received in writing by March 1, 2021. Cancellation notices received March 2 – April 15, 2021 will receive a 75% refund. No refunds will be provided after April 15, 2021. All refunds will be processed after the meeting. All cancellations must be received in writing (email is acceptable) and include the original purchase date. As a reminder, all sessions will be available live and on-demand for up to 60 days after the meeting.
